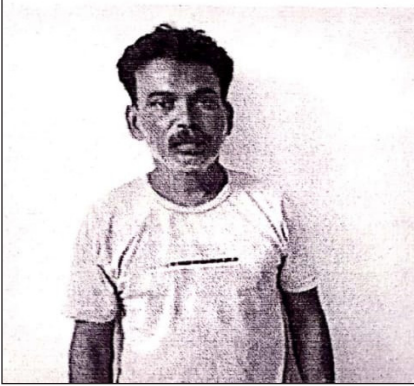

रुग्णांवरच मोफत उपचार केले जातात. तर सौम्य लक्षणे असलेल्या रुग्णांना हॉस्पिटलच्या खर्चाचा भुर्दाड सहन करावा लागत आहे, असा आरोप भाजपाचे ज्येष्ठ नगरसेवक नारायण पवार यांनी पत्राद्वारे केला आहे.
